

- We know that this will be a unique experience for all, including your state officers and staff, so I am grateful for your patience. As much as possible, we will ensure that those present in person and those participating remotely are equally able to follow the proceedings, to speak, and to vote.
- Delegates with voting rights must register with the ElectionBuddy platform to be able to vote during the business session. Only those who will be voting with ElectionBuddy will be counted in the official roll of voting members for the convention. If you have not completed the registration with ElectionBuddy, you may still do so following the instructions you have received in your email prior to this business session. If you did not receive an email, please check your spam or

junk folder. If you cannot find the email form KofC - NE please contact one of the brother Knights listed on the screen.

- Only delegates with proper credentials have the right to speak during this meeting. This is the same as "floor rights" during a typical meeting. To indicate that you would like to speak please use the "Raise Your Hand" icon on the bottom of your Zoom screen. When it is your turn to speak you will receive a notice in Zoom asking you to unmute your microphone. Click the unmute box in the notice. Once you unmute you will be able to speak. Please provide your first and last name and your Council number before making your comments. Once you are done speaking the Zoom meeting will mute your microphone. Please do not mute your phone, the system automatically mutes participants. This will speed up the process when being recognized to speak.
- If you lose your connection to the Zoom meeting, use the "Click to Join" link in the meeting invite that you received to re-join. I you lose connection to ElectionBuddy, the link to re-join will be posted on the screen at the beginning of each election. Use the user ID and Password that was in your registration email.
- The Minutes of the 2020 State Convention, and all Reports of Committees, Reports of Officers, Resolutions have been posted on the Nebraska website for review.

As the various reports of the committees have been posted to our Nebraska website prior to the State Virtual Convention, without objection they will be accepted as written and included in the minutes.

Program Director

Worthy State Deputy Mark Borytsky, Worthy State Chaplain Father Josh Brown, Worthy State Officers, Worthy District Deputies, Program Directors and Chairmen, and Brother Knights: It has been an honor and privilege to serve you this past year as State Program Director. First of all, I need to thank State Deputy Borytsky for having faith in me and asking me to fill this position. There seems to be a new challenge every day, but with every challenge there is a rewarding feeling that comes from helping a fellow Knight. I also need to thank my mentor, State Warden Mike Schaeffer. His guidance and almost daily help and encouragement are greatly appreciated. Another big thank you goes to State Membership Director Kevin Ostdiek. His knowledge of all the workings of the State Council is invaluable.

It was a fraternal year like no other and, hopefully, like we will never have again. With the state, country, and world in the unforgiving grip of a pandemic, our State Leadership Seminar was produced virtually from the Knights Event Center in Bellevue. Thank you to Council 6192 and especially to Larry and Judy Reed for the use of this wonderful facility. A big thank you also to the production crew of Rich Lowery, Mitchell Lowery, Kevin Ostdiek, and Scott Rockwell for their technology expertise. Supreme provided the State with many informative videos to help educate the Grand Knights and other council leaders in the State of Nebraska. Since this seminar was held virtually, the decision was made to mail the typical packet of information and supplies directly to each council. This ensured that every council received a copy of the State Program / Membership Book. While we would have liked to present all the educational material in person, I feel we have done a good job providing the Nebraska Knights of Columbus with the information needed for all councils to succeed.

In August 2020, Terri and I were honored to be part of the Knights of Columbus Supreme Convention, held virtually in Kearney. It was fun to spend time with the Nebraska Supreme Convention Delegates. We enjoyed the inspiring videos Supreme presented and excellent food that the Kearney hotels always provide.

In October 2020, we again met at the Knights Event Center in Bellevue to record the first-ever Educational Videos for the Knights of Columbus in Nebraska. The State Officers, Program Directors, Membership Director, Regional Growth Directors, Foundation Directors, General Agents, and even the First Lady of the Nebraska Knights of Columbus, recorded a complete Fraternal Year of information that will be presented to all Nebraska Grand Knights on a flash drive. On October 24, 2020, I was present at the State Soccer Challenge in Schuyler. Youth Chairman, Peter Peil did an excellent job of organizing this event and even with the Covid restrictions, it went on without a hitch. We had many happy soccer players at the end of the day. The Schuyler Central School District has a great facility for this event and even gave us access to

use the district's Covid thermal imaging equipment to help screen and protect the competitors, their families, and the Knights working the event.

With the whole world still in the grip of the Covid Pandemic, we again met at the Knights Event Center in Bellevue on December 11 and 12 for a virtual Mid-Year Meeting. The State Officers were able to meet in person to conduct a normal business meeting on Friday. They were also able to meet with the Foundation Directors to hear and grant requests for funds. With the help of our excellent production team, we were able to broadcast a meeting to the Knights of Columbus throughout Nebraska on Saturday, December 12th. The main goal of all of these virtual meetings is EMI (Educate, Motive, and Inform) for all Nebraska Knights.

On March 13, 2021, we were able to gather in person for the Awards Selection Meeting. Thanks go to the hospitality of Past State Chaplain Father Kenneth Borowiak and St. Michael Parish in Lincoln. Father arranged for us to use the large commons room so that we were able to social distance. It was much more efficient to be able to have this meeting in person versus the long Zoom meeting we had to have last year.

The State Free Throw contest was held April 10th at Grand Island Central Catholic High School. Again, Youth Chairman Peter Peil did a great job of putting this event together. Intellectual Disabilities

Worthy State Deputy Mark Borytsky, State Officers, Directors, and Brother Knights As I continue to serve as Director of Intellectual Disabilities for the Nebraska Knights of Columbus, I am honored to serve in this capacity. Special thanks again to Brother Don Hypse for his support and assistance along with the State Officers.

For the Fraternal Year, 2020-21, here is some basic information relative to this year's campaign. As a result of Covid-19, the pandemic has had a profound effect on our campaign. This year's Council participation rate was 59%, down from 84% last fraternal year. Out of 172 Councils, participation reports were received from 102 Councils.

This year's contributions totaled \$95,863.84 and is down from the \$207,713.64 that was collected last year. Of those Councils who submitted participation reports, one half of the monies were sent back to them to support organizations serving Intellectual Disabilities.

Request for Funds from the Foundation were received from several larger organizations who work with Intellectually Disabled individuals. Due to the shortage of funds, a decision was made by the State Officers to table the requests at this time. I have contacted those organizations and explained our current funds situation. They have all been receptive and understand why the situation exists. Several donations were made to organizations working with intellectually disabled individuals on a limited basis as approved by the State Officers.

In the future, based on funds availability, the State Officers may decide to honor some requests on a reduced basis.

Priorities for the upcoming Fraternal Year include continuing the name of the annual fundraising drive as the Intellectual Disabilities Drive rather than the Tootsie Roll Drive. Plans are also in place to continue to enforce the Supreme Council's guidelines eliminating donations to Educational Service Units, School Districts and individual Parishes. In addition, all Councils are to adhere to the charitable donations list of organizations that support individuals with Intellectual Disabilities. Plans are also in place to increase the participation rate of every Council in the State with a goal of 100%.

This year we are supporting each of the Nebraska seminaries with a \$10,000 check to support their mission.

I submitted a vocations message for each of the quarterly issues of the Knights Courier and submitted guidelines to conduct vocations promotional activities in the Annual Program book for State, District and Council leadership.

We received 7 activity reports from councils describing their vocation activities for the year. All showed exceptional effort to promote and support seminarians and others studying for a consecrated life. Two were selected as exceeding the rest in activities and promotion. The councils were: First Place – Columban Council #6192 and second place - St Joseph's Council #10163 in Benkelman-Stratton. We thank all the councils for their support of vocations and activities promoting vocations. It is essential that each of us do all we can do to encourage our young men and women to consider a religious life.





We conducted a number of one-on-one training and telephonic assistance with FS's and FCs in various councils/assemblies throughout Nebraska. Withdrawals; Demonstrated the process on how to acquire access to the Supreme website (www.kofc.org) and then demonstrated procedures within the membership management section to process activities that previously required the submission of a written paper document; How to transfer members into a council; How to report a death of a member; How to determine years of Service for Honorary and Honorary Life Status when re-entry is involved; Provided assistance to Executive Secretary concerning information required to be included in the Semi-annual Audit report; Provided Financial Secretary's guidance in computing the new fee schedule necessary for Honorary members to cover Supreme and State assessments; and other miscellaneous questions as they arose.

Councils, 4th Degree Assemblies, and many others who have supported our Nebraska State Council McGivney Foundation during the past year. This year has been like no other, and we appreciate the continued support from Individuals, Councils, Assemblies, and organizations.

This fiscal year, the Foundation saw an increase from its balance of \$526,832 on June 30, 2019 to its balance of \$600,567 on June 30, 2020. We received donations from 19 Councils totaling \$6,200 and 25 individuals whose total giving was \$13,060.

The Nebraska State Council McGivney Foundation consists of a principal endowment of donated funds never to be spent. It is the earnings from this endowment which makes it possible for us as Nebraska Knights to exemplify our charity by giving to several worthy causes in dire need of assistance located within our great state. As each of us knows, charity is the greatest of the Knights' four cardinal principals, and it is through this expression of charity that we will

always be able to do the greatest good for our Church and God's precious children, who are in most need of our assistance.

As all are aware, on April 12, 2016 the Nebraska State Council McGivney Foundation was approved by the IRS as a 501 (c) (3) organization qualified to receive tax deductible contributions. We continue our relationship with the Southern Nebraska Foundation to manage our principal endowed assets. By this relationship, our investments are managed with the utmost care and in the very best interests of our Catholic beliefs.

As always, we are most grateful to all who have assisted the foundation through their most generous contributions previously, and in the future.

Worthy State Chaplain, State Deputy Borytsky, State Officers, District Deputies, Directors and Chairmen and members of the Knights of Columbus, greetings.

The state membership team attended all required meetings scheduled by State Deputy Borytsky and additionally, participated in several in-person and virtual meetings to organize and administer the state's membership programs.

As of April 11th, 2021, Nebraska is at 40.13% of our Supreme quota with 306 new members, 458 short of our goal of 765. Additionally, five councils have met or exceeded their individual membership goals for the year, most notably Council 16680, St. John Paul II – UNO council, which has already reached 766.67% of their quota by adding 23 new Knights to their council. Another four councils are at 75% or above. The membership team continues to work with the State Deputy and Officers to call councils and District Deputies, offering encouragement and assistance that they may need in obtaining their individual goals.

Pursuing membership goals within a pandemic has presented some unique challenges and opportunities throughout this year. It has been difficult for our councils to hold almost any

church drives as the Sunday obligation to attend Mass has been suspended and many councils were unable to meet in person or conduct regular activities throughout this year. We also were not able to meet in person with councils for most of the year and needed to engage council officers through virtual meetings and phone calls for the better part of this year. However, Supreme did take this into account and reduced our state goal as well as adjusting all council's membership quota for the year. This has given many councils a better opportunity to achieve their membership quota than in recent years. Several councils have taken advantage of this and are pursuing their quota and Star Council status.

From the beginning of the year, we have had to adjust our message to councils to encourage them to do anything that they can to support their council's membership: reaching out to existing members to make sure that they are doing well and reestablishing contact with old members. We have also encouraged more personal recruitment of family members, neighbors and co-workers since group recruiting has been difficult at best, and often not allowed due to local health restrictions. Many councils have taken this lull in activities to review their council roster and focus on membership retention issues. As a result of this, many inactive members either withdrew their membership or were suspended by the council. As a result, our Year-to-Date Membership has declined by 202 members to 26,449.

Our intake was steady, but not strong throughout the first eight months of the year. During these times, the team has encouraged use of the eMembership program and virtual degrees to accomplish almost all of this growth. In the last two months, as vaccines for COVID-19 have been distributed throughout the state and most areas of the state have reduced or removed their health restrictions, our growth has strengthened, and several councils have begun to hold live degrees again. The Membership team is continuing to encourage councils to pursue whatever growth opportunities they feel comfortable doing and using all tools that are available to them.

Supreme did not set a New Council Development goal for the year, and Nebraska has been unable to pursue the two possible new councils, both Hispanic, that we identified last year. The first is in Sacred Heart parish in Crete, which already has an English-speaking council, but which has a large and vibrant Hispanic community, which could be helped by establishing a Hispanic council. The second is at Cristo Rey parish in Lincoln. As soon as restrictions are relaxed, these plans will be revisited.

Finally, I personally wish to thank the membership team and all of the State Officers for their help and dedication that they have given the Knights of Columbus in the state of Nebraska. In particular, our Worthy State Deputy Mark Borytsky has been a great source of encouragement to our councils, Membership Team and myself. He has maintained an upbeat and positive attitude that has picked me up when I felt discouraged by our lack of progress. I wish to thank him for his great leadership through difficult challenges.

We meet every other month and discuss membership, council activities and how we can help each other in our projects.

Council 9771 is an excellent council in both measurable and non-measurable ways. Their meetings are well attended and efficient. Their paperwork is always on time or ahead of schedule. Their membership is eager to be involved and is always ready to jump in and do what needs to be done. Council 9771 got creative to make up for the lack of income from cancelled fish frys in 2020, and volunteered to do moving services for people in the parish who would in turn donate to the council. If all councils had their level of involvement and enthusiasm, Nebraska would be in amazing shape every year. Their recruiting has been strong this year despite COVID and I believe they are on target for Star Council this year.

Council 9918 moved to virtual meetings for most of the fiscal year, but those virtual meetings were well-attended. Their new F.S. has grown by leaps and bounds and is getting his footing now and their paperwork is now on-time. As things have started to open up again in 2021, Council 9918 has emerged active again. Some of the leaders at St. Joan of Arc are involved in both the Knights and the Men's' Group. Instead of being at odds with one another, they join forces, proving to us at other parishes that it can certainly be done. That said, both their programs and their recruitment fell victims to COVID this year and Star Council is likely not attainable this year. There has also been a bit of a lack of interest in becoming leaders of the council as most of the members interested in being GK have already done so at least once.

Council 10895, my home council, had a few virtual meetings, but most of the year has used a hybrid approach and held socially distanced meetings live and had members join on Zoom as well. Our meeting attendance is down a bit through the pandemic despite the accommodation though. We tried takeout-only fish frys this year and to our surprise managed to pull in around 75% of our normal profits. We also finished a year-long renovation in our school cafeteria kitchen, adding a fry-room to secure our ability for future fundraising. Our Chaplain, Father

Tom is a regular attendee and good supporter of the council. While our programs and insurance is on track for awards this year, it looks like we are not on track with membership to make Star Council despite our recent church drive complete with flyers and pulpit announcements.

Council 11600 is a very interesting council. On paper it's 56 members. In actuality, it's probably 10 guys, most of whom show up to every meeting and are involved in every event. They seemingly help the parish out with whatever needs help. Their meeting agendas are impressive and this core of guys is extremely well organized. Their F.S. is on point with the paperwork and has been for many many years. This is a close-knit group of guys that dedicate an amazing amount of time and effort to the council and the parish. The lack of new blood at St. Bernards makes it hard for recruiting. They are unlikely to achieve Star Council.

At the District level, we had our Soccer shootout and our Free Throw contest. We were grateful to Glen Kampschneider (District 34) for hosting the Regional Free Throw contest as well. I've attended nearly every council meeting over the last three years of these four councils. District 3 is filled with generous and thoughtful Knights.

Wallace Gretna, Council 10160 St. Stephen the Martyr Omaha, Council 10894 St. Joseph Springfield. Council reports were submitted, and youth protection is up to date. Activities have included, but are not limited to, One Rose-One Life, RSVP Program, Fish Fries were conducted by three of the four councils using carry out or drive through options, two councils held free throw contests and a district contest was held as well, no councils held a soccer challenge. There was not a lot of degree work done due to the pandemic, as such membership district wide down as we failed to keep up with the losses due to suspension, withdrawal, and death. Following is a summary of my assessment of each council:

Council 7740: Monthly meetings were suspended for a few months, but once they restarted, they were well attended by the council membership and meetings are run efficiently. I have found the council to be very charitable and they take on many projects to provide support to those in need in the parish and the larger community. As of this writing making star council is highly unlikely. Recruitment and retention efforts are the one area I see that needs improvement.

Council 10047: Monthly meetings were held virtually for a few months, then back to in person meetings which are well attended by the council membership. The council is incredibly involved in the local community and schools taking part in my projects, including an annual track meet. The council is exceptionally good at getting their "paperwork" done. It seems unlikely that star council will be achieved.

Council 10160: This is my home council. Monthly meetings are well attended and efficiencies in the meeting have occurred. For a few months, the meetings were held virtually, today they are a combined virtual and in person type meeting. The council is highly active providing aid and assistance to the church and community. The council membership team is

Due to COVID-19 they did the fish fries Drive Thru Only and were very successful. They also continue with the KC Living rosaries at Brother Knight Funerals. The council was the founder of the High School Honor Chord program for the state and is now being looked at supreme wide. This will be West Point's fifth year for giving out Honor Chords to the Graduating senior men. Through the Pandemic this council did continue to meet every other month.

Council #15068 St. Patrick's Tekamah is currently has not recruited any members but have a couple on the list. They normally are very active in fundraisers for their community with breakfasts and fish fry's. Unfortunately, with the pandemic they haven't done any events. They participated in the 2021 Tootsie roll drive and are still doing a great job promoting the intellectual disabilities program. They have had the same grand knight for 7 years and are not having any luck getting new members to attend meetings.

Council #11810 St. John the Baptist Pender has not recruited any new members, but are working hard in their parish to make an impact in the community and church. In 2020 they continued their efforts in the Intellectual Disabilities drive. They are a small council but are trying hard to promote the Knight of Columbus through One Rose One Life and the Tootsie Roll Drives. Their

events have been cancelled also due to the Covid-19 pandemic. They hold many fundraisers and have scholarships for graduating seniors, and also support families in their community with a disaster fund which they used in the past for tornado relief. They have had the same grand knight for 6 years and are not able to get any more members to attend meetings.

All 4 parishes excluding West Point, have been losing parish members due to death, and not many youths are moving back to these communities. It will be interesting to see what happens when all or most of these are combined parishes if they will stay independent. It is very difficult to recruit members when there are not many attendees at mass on a weekly basis due to Covid. I would believe this would pick up at the end of May sometime. I am excited to be able to see the future of evangelizing the Knights of Columbus in Nebraska with this new "in church" exemplification. This will be my last couple months of being DD, I really enjoyed the network of brothers across the state and look forward to being more active in my local council and assembly going forward.

EXECUTIVE SECRETARY

Worthy State Deputy Mark Borytsky, State Officers, Delegates and Brother Knights attending the 116th Virtual State Convention.

I attended to all routine correspondence for the State Council and mailed out such communications as the State Officers required. I attended all meetings called by the State

Deputy. I prepared the minutes and proceedings of the 115th Annual Virtual State Meeting for 2020. I prepared and mailed to all councils the semi-annual per capita billings for State Secretary Richardson. During this past year I assisted in preparing for this convention by preparing and mailing all the documents and information sheets to our subordinate councils. I prepared new correspondence with detailed instructions for our virtual convention ad well as validated the delegate roster for the phone call virtual convention.

During this past year, the state council offered 42 masses for the members of the state council with the Columban Fathers Foreign Missionary Society. These are offered for serious illnesses and the passing of the brother knight or immediate family members. The offices revised the policy on under what circumstances masses were offered. Formalizing verbal changes over the years.

The reporting of our subordinate councils is up for the same time as last year; for the Report of Officers, we are 95% complete; the Report of Service Personnel, we are 81% complete; and the Fraternal Activity we are 88% complete. The Semi-Annual Audit for the period ending June 30, 2020 is 81% complete and for the period ending December 31, 2020 is 75% complete. At this time, we have 9 councils that are two years or more reports delinquent, our Supreme council has ended the bond on the Financial Secretary and Treasurer for these councils. It is the same councils year-after-year that do not submit these vital reports; some improvement is noted in the submission of these reports. There continues to be an increase in the number of councils filing these and other reports on-line with Supreme.

For the 2020-2021 fraternal year I prepared the annual directory for the State of Nebraska. This is a time-consuming task. I continued publishing a monthly email with directory changes to keep all update on changes to our directory. I maintain an electronic email mailing list for the purpose of notifying our members of requests for our prayers as well as sending pertinent information on our program events and exemplifications being conducted across the state. Constant Contact to communicate with our state council and councils continues to work well. The cost to the state council is \$450 per year. I have approximately 2,000 addresses, subordinate councils send these on to their individual members and we estimate that approximately 19,000 brother knights receive these requests for our prayers. All councils have at least one email address.

I reviewed the Courier for content, etc., prior to publication of each issue.

In closing, I wish to give a very special thank you to State Deputy Mark Borytsky for the opportunity to continue to serve as the State Council Executive Secretary. I have served in this role for 23 years; I look forward to continuing my service to our order.

 - 3. RESOLVED, the State Council shall prepare, publish, and distribute a State Directory for the 2021-2022 Columbian Year and pay the actual expenses thereof.
 - 4. RESOLVED, the State Council shall publish the <u>Knights Courier</u> quarterly for the 2021-2022 Columbian Year and pay the fair and reasonable expenses thereof; and FURTHER RESOLVED, each issue of the <u>Knights Courier</u> published during the 2021-2022 Columbian Year shall be delivered to each member of each subordinate council as reflected by the membership records maintained at the office of the Supreme Council by electronic transmission (email), U.S. Postal Service, hand-delivery, or other reasonably reliable means as determined and directed by the State Council Executive Committee ("Executive Committee") and that the fair and reasonable expenses thereof be paid by the State Council.

INDEPENDENT AUDITORS' REPORT

To the State Officers and Directors Knights of Columbus Nebraska State Council Bellevue, Nebraska

We have audited the accompanying financial statements of Knights of Columbus Nebraska State Council (a nonprofit organization), which comprise the statements of assets, liabilities, and net assets - modified cash basis for the years ended June 30, 2021 and 2020, and the related statements of revenues, expenses, and changes in net assets - modified cash basis and statements of functional expenses - modified cash basis, for the years then ended, and the related notes to the financial statements.

KNIGHTS OF COLUMBUS NEBRASKA STATE COUNCIL NOTES TO FINANCIAL STATEMENTS

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Organization

Knights of Columbus Nebraska State Council (the Council), is a Nebraska not-for-profit fraternal organization exempt from federal income tax under Section 501(c)(8) of the U.S. Internal Revenue Code. The Council commenced operations in 1902 and operates as a subordinate state organization of the national organization located in New Haven, Connecticut, known as the Knights of Columbus Supreme Council. The Council is composed of Catholic men dedicated to the principles of charity, unity, fraternity, patriotism, and religious vocation. Its support comes primarily from local councils across Nebraska in addition to receipts generated from an annual convention and various donations. The Council fulfills its exempt purpose by providing financial assistance, organizing events, and providing services related to its mission.

Basis of Accounting

The Council maintains its books and records, and reports its financial operations on the modified cash basis of accounting. As the accompanying statement of assets, liabilities, and net assets - modified cash basis does not include accounts receivable, accounts payable, and other accrued revenues and expenses, the financial statements do not reflect the financial position or the results of operations of the Foundation in conformity with generally accepted accounting principles. The statements reflect investments at cost basis.

Financial Statement Presentation

The financial statements report amounts by class of net assets, as required by ASU 2016-14, Not-for-Profit Entities (Topic 958): Presentation of Financial Statements of Not-for-Profit Entities. As such, net assets, revenues, gains, and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets and changes therein are classified and reported as follows:

Net Assets Without Donor Restrictions

Net assets without donor restrictions are resources available to support operations and not subject to donor restrictions.

Net Assets With Donor Restrictions

Net assets with donor restrictions are resources that are subject to donor-imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both, and are reported in the statements of activities as net assets released from restrictions.

Contributions

The Council utilizes FASB ASC 958-605, *Not-for-Profit Entities Revenue Recognition*. This standard requires that unconditional promises to give (pledges) be recorded as receivables and revenues and requires the organization to distinguish between contributions received for each net asset category in accordance with donor-imposed restrictions. Conditional promises to give are recognized only when the conditions on which they depend are substantially met and the promises become unconditional.

Revenue Recognition

Membership dues are recognized as revenue in the accounting period the revenue is received.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting used by the Council requires management to make estimates and assumptions that affect certain reported amounts and disclosures; accordingly, actual results could differ from those estimates.

Cash and Cash Equivalents

The Council considers all highly liquid investments purchased with a maturity of three months or less to be cash equivalents. At June 30, 2021 and 2020, the Council had no cash equivalents.

Investments

Investments are recorded at cost basis as provided by the custodians of each endowment.

Income Taxes

Under Section 501(c)(8) of the Internal Revenue Code, the Council is exempt from federal income tax on all income except unrelated business income as noted under Section 511 of the Internal Revenue Code. Internal Revenue Code Section 513(a) defines an unrelated trade or business of an exempt organization as any trade or business which is not substantially related to the exercise or performance of its exempt purpose.

The Council utilizes the provisions of FASB ASC 740-10, *Accounting for Uncertain Tax Positions*. The Council continually evaluates expiring statutes of limitations, audits, proposed settlements, changes in tax law, and new authoritative rulings. The Council believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that would be material to the financial statements.

Functional Expenses

Accordingly, a detailed listing breaking out these costs is reflected in the statements of functional expenses - modified cash basis.

Advertising

Advertising costs were recorded as expended. The advertising expenses for the years ended June 30, 2021 and 2020, were \$200 and \$1,000, respectively.

NOTE 2. FINANCIAL INSTRUMENTS - CONCENTRATIONS OF CREDIT RISK

The Council maintains cash balances at a financial institution located in Nebraska. Accounts at this institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to a balance of \$250,000. At June 30, 2021 and 2020, the Council had uninsured balances totaling \$157,976 and \$153,522, respectively. The Council has not experienced any losses on such accounts and management believes the risk is mitigated by maintaining all deposits in high quality financial institutions.

NOTE 3. ENDOWMENT FUND

The Council's endowment consists of one fund established to fulfill the Council's exempt purpose. Its endowment includes both donor-restricted funds and earnings on investments that have accumulated and have not been distributed. As required by generally accepted accounting principles, net assets associated with the endowment fund are classified and reported based on the existence or absence of donor-imposed restrictions.

The State Officers and Directors of the Council have interpreted the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the Council classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts donated to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. In accordance with UPMIFA, the Council considers the following factors in making a determination to appropriate or accumulate donor-restricted endowment funds: (1) the duration and preservation of the fund, (2) the purposes of the donor-restricted endowment fund, (3) general economic conditions, (4) the possible effect of inflation and deflation, (5) the expected total return from income and the appreciation of investments, (6) other resources of the Council, and (7) the Council's investment policies.

Investment Return Objectives, Risk Parameters, and Strategies

The Council has adopted investment and spending policies, approved by the State Officers and Directors, for endowment assets that attempt to provide a predictable stream of funding to programs supported by its endowment fund while also maintaining the purchasing power of those endowment assets over the long term. Accordingly, the investment process seeks to achieve an after-cost total real rate of return, including investment income as well as capital appreciation, which exceeds the annual distribution with acceptable levels of risk. Actual return in any given year may vary from this amount. Investment risk is measured in terms of the total endowment fund; investment assets and allocation between asset classes and strategies are managed to not expose the fund to unacceptable levels of risk.

Spending Policy

The Council shall award grants and support as approved by the State Officers and Directors on an annual basis and these shall only be awarded from the Endowment Fund's earnings. The Council considered the long-term expected return on its investment assets, the nature and duration of the individual endowment funds, many of which must be maintained in perpetuity because of donor-restrictions, and the possible effects of inflation. This is consistent with the Council's objective to maintain the purchasing power of the endowment assets as well as to provide additional real growth through new gifts and investment return.

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Organization

Knights of Columbus Intellectual Disabilities Foundation of Nebraska, Inc. (the Foundation), is a Nebraska nonprofit corporation that was established on November 12, 1975. Its purpose is to provide assistance to organizations, schools, and groups throughout the state of Nebraska who work with individuals facing intellectual disabilities. The Foundation's support comes primarily from individual donors of the general public.

Basis of Accounting

The Foundation prepares its financial statements on the cash basis of accounting; consequently, these statements represent a summary of the cash activity of the Foundation and do not include certain transactions that would be included if the Foundation prepared its financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), as applicable to nonprofit organizations. Under the cash basis, receipts are recognized when collected rather than when earned, and disbursements are recognized when paid rather than when incurred. Consequently, these financial statements are not intended to present financial position or results of operations in conformity with accounting principles generally accepted in the United States of America, as applicable to nonprofit organizations.

Financial Statement Presentation

The financial statements report amounts by class of net assets, as required by ASU 2016-14, Not-for-Profit Entities (Topic 958): Presentation of Financial Statements of Not-for-Profit Entities. As such, net assets, revenues, gains, and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets and changes therein are classified and reported as follows:

Net Assets Without Donor Restrictions

Net assets without donor restrictions are resources available to support operations and not subject to donor restrictions.

Net Assets With Donor Restrictions

Net assets with donor restrictions are resources that are subject to donor-imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction

expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both, and are reported in the statements of activities as net assets released from restrictions.

There were no net assets with donor restrictions as of June 30, 2021 and 2020.

Contributions

The Foundation utilizes FASB ASC 958-605, *Not-for-Profit Entities Revenue Recognition*. This standard requires that unconditional promises to give (pledges) be recorded as receivables and revenues and requires the organization to distinguish between contributions received for each net asset category in accordance with donor-imposed restrictions. Conditional promises to give are recognized only when the conditions on which they depend are substantially met and the promises become unconditional.

Use of Estimates

The preparation of financial statements in conformity with the cash basis of accounting used by the Foundation requires management to make estimates and assumptions that affect certain reported amounts and disclosures; accordingly, actual results could differ from those estimates.

Cash and Cash Equivalents

The Foundation considers all highly liquid investments purchased with a maturity of three months or less to be cash equivalents. At June 30, 2021 and 2020, the Foundation had no cash equivalents.

Income Taxes

The Foundation is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. However, income from certain activities not directly related to the Foundation's tax-exempt purpose is subject to taxation as unrelated business income.

The Foundation utilizes the provisions of FASB ASC 740-10, Accounting for Uncertain Tax Positions. The Foundation continually evaluates expiring statutes of limitations, audits, proposed settlements, changes in tax law, and new authoritative rulings. The Foundation believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that would be material to the financial statements.

Functional Expenses

The costs of providing various programs and other activities have been summarized on a functional basis in the statement of functional disbursements. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

NOTE 2. CONCENTRATION OF CREDIT RISK

The Foundation had deposits at one financial institution. At June 30, 2021 and 2020, none of the deposits were in excess of the \$250,000 federally insured limit by the Federal Deposit Insurance Corporation (FDIC). At June 30, 2021 and 2020, the Foundation's cash balances were fully insured.

NOTE 3. LIQUIDITY AND AVAILABILITY OF RESOURCES

The Foundation has \$36,969 of financial assets available within one year of June 30, 2021, to meet cash needs for general expenditure consisting of cash of \$36,969. None of the financial assets are subject to donor or other contractual restrictions that make them unavailable for general expenditure within one year of June 30, 2021. The Foundation has a goal to maintain financial assets, which consist of cash on hand to meet 60 days of normal operating expenses.

NOTE 4. RISKS AND UNCERTAINTIES

The COVID-19 pandemic (the pandemic), whose effects first became known in January 2020, is having a broad negative impact on commerce and financial markets around the world. The United States and global markets experienced significant declines in value resulting from uncertainty caused by the pandemic. The extent of the impact of COVID-19 on the Foundation's operational and financial performance will depend on certain developments, including the duration and spread of the outbreak and its impacts on the Foundation's contributors, vendors, and members, all of which cannot be determined at present. Accordingly, the extent to which COVID-19 may impact the Foundation's financial position and changes in net assets and cash flows is uncertain and the accompanying financial statements include no adjustments relating to the effects of this pandemic.

NOTE 5. SUBSEQUENT EVENT

In preparing the financial statements, the Foundation has evaluated events and transactions for potential recognition or disclosure through May 2, 2022, the date the financial statements were available to be issued.

INDEPENDENT AUDITORS' REPORT

To the Board of Directors Nebraska State Council McGivney Foundation Bellevue, Nebraska

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Business

The Nebraska State Council McGivney Foundation (the Foundation) is a Nebraska non-profit corporation exempt from federal income tax under Section 501(c)(3) of the U.S. Internal Revenue Code. The Foundation was established November 30, 2015, in Bellevue, Nebraska. The primary purpose of the Foundation is to serve as an endowment fund to receive donor contributions from the general public, which are invested in perpetuity. The Foundation's investment income and earnings are available to be used to provide grants to charitable projects and for the benefit of other good works.

Basis of Accounting

The Foundation maintains its books and records and reports its financial operations on the modified cash basis of accounting. As the accompanying statement of assets, liabilities, and net assets - modified cash basis does not include accounts receivable, accounts payable, and other accrued revenues and expenses, the financial statements do not reflect the financial position or the results of operations of the Foundation in conformity with generally accepted accounting principles. The statements do reflect the fair value of investments.

Financial Statement Presentation

The financial statements report amounts by class of net assets as required by ASU 2016-14, *Not-for-Profit Entities* (Topic 958): *Presentation of Financial Statements of Not-for-Profit Entities*. As such, net assets, revenues, gains, and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets and changes therein are classified and reported as follows:

Net Assets Without Donor Restrictions

Net assets without donor restrictions are resources available to support operations and are not subject to donor restrictions.

Net Assets With Donor Restrictions

Net assets with donor restrictions are resources that are subject to donor-imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both, and are reported in the statement of revenues, expenses, and other changes in net assets - modified cash basis as net assets released from restrictions.

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Contributions

The Foundation utilizes FASB ASC 958-605, *Not-for-Profit Entities Revenue Recognition*. This standard requires that unconditional promises to give (pledges) be recorded as receivables and revenues and requires the Foundation to distinguish between contributions received for each net asset category in accordance with donor-imposed restrictions. Conditional promises to give are recognized only when the conditions on which they depend are substantially met and the promises become unconditional.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting used by the Foundation requires management to make estimates and assumptions that affect certain reported amounts and disclosures; accordingly, actual results could differ from those estimates.

Cash and Cash Equivalents

The Foundation considers short-term highly liquid investments to be cash and cash equivalents provided that they are both readily convertible to cash and had an original maturity of three months or less when purchased. The Foundation had no cash equivalents at June 30, 2021.

Investments

The Foundation utilizes FASB ASC 958-320, Accounting for Certain Investments Held by Not-for-Profit Organizations. FASB ASC 958-320 sets standards of reporting at fair value certain investments, and debt and equity securities held by not-for-profit organizations. Therefore, investments in equity securities that have a readily determinable fair value and all investments in debt securities are stated at fair value, with gains and losses included in the statement of revenues, expenses, and other changes in net assets - modified cash basis. Fair value is determined by quoted market values. Investments in money markets are recorded at cost, which approximates fair value.

Income Taxes

The Foundation is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. However, income from certain activities not directly related to the Foundation's tax-exempt purpose is subject to taxation as unrelated business income. In addition, the Foundation qualifies for the charitable contribution deduction under Section 170(b)(1)(A) and has been classified as an organization other than a private foundation under Section 509(a)(2).

The Foundation utilizes the provisions of FASB ASC 740-10, Accounting for Uncertain Tax Positions. The Foundation continually evaluates expiring statutes of limitations, audits, proposed settlements, changes in tax law, and new authoritative rulings. The Foundation believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that would be material to the financial statements.

NOTE 3. INVESTMENTS

The Foundation utilizes FASB ASC 820-10, Fair Value Measurements, which provides a framework for measuring fair value under generally accepted accounting principles. FASB ASC 820-10 applies to all financial instruments that are being measured and reported on a fair value basis.

As defined in FASB ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Foundation uses various methods including market, income, and cost approaches. Based on these approaches, the Foundation often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about the risk and/or risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market-corroborated, or generally unobservable inputs. The Foundation utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Foundation is required to provide the following information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 - Valuations for assets and liabilities traded in active exchange markets, such as the New York Stock Exchange. Level 1 also includes U.S. Treasury and federal agency securities and federal agency mortgage-backed securities, which are traded by dealers or brokers in active markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2 - Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.

NOTE 3. INVESTMENTS (Continued)

Level 3 - Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models, and similar techniques, and not based on market exchange, dealer, or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

For the fiscal year ended June 30, 2021, the application of valuation techniques applied to similar assets has been consistent. The following is a description of the valuation methodologies used for instruments measured at fair value:

Marketable Equity and Debt Securities

The fair value of marketable equity and debt securities is the market value based on quoted market prices, when available, or market prices provided by recognized broker dealers. If listed prices or quotes are not available, fair value is based upon externally developed models that use unobservable inputs due to the limited market activity of the instrument.

Fair Value on a Recurring Basis

The table below presents the balances of assets measured at June 30, 2021, at fair value on a recurring basis.

Management evaluates securities for other than temporary impairment at least on a quarterly basis and more frequently when economic or market concerns warrant such evaluation. Consideration is given to (1) the length of time and the extent to which the fair value has been less than cost, (2) the financial conditions and near-term prospects of the issuer, and (3) the intent and ability of the Foundation to retain its investments in the issuer for a period of time sufficient to allow for any anticipated recovery in fair value. As management has the ability to hold securities for the foreseeable future, no declines are deemed to be other than temporary.

NOTE 4. ENDOWMENT FUND

The Foundation's endowment consists of one fund established to fulfill the Foundation's exempt purpose. Its endowment includes both donor-restricted funds and earnings on investments that have accumulated and have not been distributed. As required by generally accepted accounting principles, net assets associated with the endowment fund are classified and reported based on the existence or absence of donor-imposed restrictions.

The Board of Directors of the Foundation has interpreted the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the Foundation classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts donated to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. In accordance with UPMIFA, the Foundation considers the following factors in making a determination to appropriate or accumulate donor-restricted endowment funds: (1) the duration and preservation of the fund, (2) the purposes of the donor-restricted endowment fund, (3) general economic conditions, (4) the possible effect of inflation and deflation, (5) the expected total return from income and the appreciation of investments, (6) other resources of the Foundation, and (7) the Foundation's investment policies.

Investment Return Objectives, Risk Parameters, and Strategies

The Foundation has adopted investment and spending policies, approved by the Board of Directors, for endowment assets that attempt to provide a predictable stream of funding to programs supported by its endowment fund while also maintaining the purchasing power of those endowment assets over the long term. Accordingly, the investment process seeks to achieve an after-cost total real rate of return, including investment income and capital appreciation, which exceeds the annual distribution with acceptable levels of risk. Actual return in any given year may vary from this amount. Investment risk is measured in terms of the total endowment fund; investment assets and allocation between asset classes and strategies are managed to not expose the fund to unacceptable levels of risk.

Spending Policy

The Foundation shall award grants and support as approved by the Board of Directors on an annual basis, and these shall only be awarded from the Endowment Fund's earnings. The Foundation considered the long-term expected return on its investment assets; the nature and duration of the individual endowment funds, many of which must be maintained in perpetuity because of donor-restrictions; and the possible effects of inflation. This is consistent with the Foundation's objective to maintain the purchasing power of the endowment assets, as well as to provide additional real growth through new gifts and investment return.

NOTE 5. NET ASSETS WITH DONOR RESTRICTIONS

Net Assets Restricted by Purpose or Time

Net assets restricted by purpose or time consist of the earnings from the endowment fund. These funds are temporarily restricted until restrictions have been satisfied. At June 30, 2021, the total amount restricted is \$256,146.

Net Assets Restricted in Perpetuity

Net assets restricted in perpetuity consist of donations of cash and life insurance policies from the public to the Foundation's endowment fund. By donor restriction, the corpus of the fund is permanently restricted, and the earnings may be spent to fulfill the Foundation's exempt purpose. Endowment fund assets that were permanently restricted by donors totaled \$593,265 at June 30, 2021.

NOTE 6. CASH VALUE - LIFE INSURANCE

At June 30, 2021, the Nebraska State Council McGivney Foundation owns and is the beneficiary of life insurance contracts with the Knights of Columbus. The life insurance contracts are reported at their respective cash surrender values, net of any policy loans, which totaled \$97,192 at June 30, 2021.

NOTE 7. LIQUIDITY AND AVAILABILITY OF RESOURCES

The Foundation has \$4,150 of financial assets available within one year of June 30, 2021, to meet cash needs for general expenditures consisting of cash of \$4,150. None of the financial assets are subject to donor or other contractual restrictions that make them unavailable for general expenditures within one year of June 30, 2021. The Foundation has a goal to maintain financial assets, which consist of cash, on hand to meet 60 days of normal operating expenses.

NOTE 8. RISKS AND UNCERTAINTIES

The COVID-19 pandemic, whose effects first became known in January 2020, is having a broad negative impact on commerce and financial markets around the world. The United States and global markets experienced significant declines in value resulting from uncertainty caused by the pandemic. The extent of the impact of COVID-19 on the Foundation's operational and financial performance will depend on certain developments, including the duration and spread of the outbreak and its impacts on the Foundation's contributors, vendors, and members all of which cannot be determined at present. Accordingly, the extent to which COVID-19 may impact the Foundation's financial position and changes in net assets and cash flows is uncertain and the accompanying financial statements include no adjustments relating to the effects of this pandemic.

NOTE 9. SUBSEQUENT EVENTS

In preparing the financial statements, the Foundation has evaluated events and transactions for potential recognition or disclosure through May 13, 2022, the date the financial statements were available to be issued.
