Leadership Training Seminar Wrapup





Fellowship, Honors, Tips, New Programs and Much More

Words from our State Deputy

Brother Knights,

The Leadership Training Seminar this July was a wonderful experience. Connie and I enjoyed seeing friends and making new ones throughout the weekend. The State Program and Membership teams put on a dynamic, valuable, and informative event for District Deputies and Council Leadership.

The Dodd decision that overturned Roe is an answer to many years of prayer. The answer to our prayers creates another need. Our work is not done. It is just starting, and prayer is still needed. As Knights, we are called to be men of action. Now more than ever, we must be ready to support women and their children in our communities. The Aid and Support After Pregnancy (ASAP) program from Supreme does just that. It focuses directly on resource centers and maternity homes for women who choose life.

With the advent of a new fraternal year, we are again asking councils to focus on programs that develop faith, promote fraternity with other Catholics, and serve their parish and community. It is our belief that good programs will promote a return to Mass. These same programs will offer the opportunity for conversations about membership.

My take on membership: The latest numbers show, Order-wide, we lose 180 or so men each day. These numbers also show, Order-wide, we gain on average each day between 210-230 men. The I-80 Collar Series sponsored by the Nebraska Knights of Columbus State Council was played on June 12, 2022, at the University of Nebraska Omaha, Tal Anderson Field.

After a two-year hiatus, the priests from the Archdiocese of Omaha played the priests from the Diocese of Lincoln in a softball game.

The game is a way to celebrate Father's Day and raise funds. All proceeds from this year's game assist in promoting vocations and religious life in the Diocese of Lincoln and the Archdiocese of Omaha. The gates opened at 3:00 p.m., and the game started at 4:00 p.m.

Tickets were \$10.00 for adults and \$5.00 for youth, 4-17 years of age. Family packs were \$30.00 for 2 adults and 4 youths. Priests and Religious and children under 4 years were free.

The game drew about 1,200 spectators, who watched the Lincoln clerics win. The final score was 17 to 9. The traveling trophy was awarded to the Diocese of Lincoln. They hold a 5-1 record in the series.

New Programs of Interest

The following are some of the new programs and opportunities Supreme has implemented this year.

Aid and Support After Pregnancy (ASAP)

This program is intended to encourage Councils to support Pregnancy Resource Centers and Maternity Homes.

Supreme gives \$100 to centers that councils support with \$500 donations, up to \$400 per center, per year, per council. The Nebraska Culture of Life Foundation is also matching Supremes' donations with the same amount. If your council donates \$500 to a qualifying center or home, it turns out that the recipient will receive \$700.

Details can be found on the Supreme website under the Faith In Action "Life" category.

Eucharistic Processions

Supreme Council Updates

There is much going on within the Knights of Columbus. Here are a few updates from Supreme.

The Aid and Support After Pregnancy program (ASAP) focuses on providing support to pregnancy centers, maternity homes, and locations where Supreme has placed an ultra-sound machine.

It will operate similar to the RSVP program. For every \$500 a council donates to an approved center (up to \$2,000), Supreme will send the council a \$100 check payable to the center.

Free online membership will continue. For anyone joining the Knights online using the new code **blessedmcgivney**, the first year of membership is free. Once they take part in the Charity, Unity, Fraternity (CUF) exemplification, the financial secretary transfers them into the council via Member Management.

The Affiliate program will enter Phase III with its international focus. This program has returned over

10,000 members to councils so far.

The affiliate members raised over \$150,000 for Ukraine. We are unsure of when the next window for Nebraska will be. If it happens, it will occur sometime in the spring of 2023.

One modification to the Founders Award is that a council must hold two fraternal benefit nights and have seven member or member-eligible attendees. It is an honor system. It must be reported to the General Agent within seven days of the event. The award is a certificate. Only the Star Council Award is a plaque.

The McGivney award has been changed to a minimum of five members and maximum of fifteen members. The award is a certificate. Only the Star Council Award is a plaque.


Membership cards will no longer contain signatures.

There is no longer a form 450 to submit, and the DD form 944 happens once per year. This is due September 1.

Per capita is an assessment on every member of the Knights of Columbus in all jurisdictions. Only Disabled and Honorary Life members are excluded from this yearly per capita assessment. Both the State Council and Supreme have per capita assessments.

Where does the money go?

The state assessment is designed to assist the State Council in funding items such as programs, conventions, Knights Courier, and the other expenses that are associated with running an organization like ours. Your State Council does not have other fund-raising programs to pay the general expenses of the State Council. Fundraisers, such as Tootsie Roll

Drive, Buck-a-month, One Rose – One Life, and the Vocation Lottery, all go to the Foundations that promote them for their use and that of the local Councils.

How much is it?

State per capita assessment

At this year's State Convention, the delegates voted to raise the State per capita by \$1.00 per member per year starting with the July 1, 2022, billing and \$1.00 per member per year starting July 1, 2023. Your state per capita invoice is sent two times each fiscal year. Invoices are sent directly to your council's Financial Secretary and are to be paid from your council's annual dues. Starting the 2022 Fraternal year, \$9.75 per member is assessed by the State Council and is your council's State per capita billing. One part will be billed July 1, 2022, and due by September 1, 2022, for \$4.88 per member. The remainder will be billed at \$4.87 per member on January 1, 2023, and due by March 1, 2023.

Supreme per capita assessment.

Supreme per capita assessment is currently \$4.50 per member per billing (twice yearly) and is your council's Supreme per capita billing. These invoices need to be downloaded from the Supreme website as Supreme no longer mails the assessments to the councils.

Where do the assessed numbers come from?

For both per capita invoices, the State Council uses the number of members that each council has on the Supreme membership roster as of July 1st of that current fiscal year. This is another reason why it is important that your council's Financial Secretary accurately maintains and updates your membership records with Supreme.

The Inter-Council Competition (ICC) Just Got A Whole Lot Easier

The Inter-Council Competition (ICC) is back for its eighth year, and your council still has a chance to take home the coveted ICC Championship Belt.

The ICC program has been designed to encourage service to the Knights of Columbus, strengthening our Faith, Families, and Communities, and supporting all Life.

This year, we have made the submission process for ICC forms simpler to aid in the process. No more fillable PDF files to download, fill-out, save, and email to several people.

Now, all submissions can be completed directly through the State Website and can be found on the Inter-Council Competition Program Page (https://nebraskakofc.org/programs/icc-forms.html).

The layout on this page has changed slightly from previous years. As we are working to update all of the forms, you will notice two different buttons on the web page. The buttons that say to "Download" a specific form are still the fillable PDF files. We are working quickly to update these and hope to have them all converted to the new submission forms no later than the end of this year.

The new submission forms can be found by clicking on a button saying "Go to." This will take you to a new web page with a form to fill out on line. Certain information will be <u>required</u> to submit each form. For example, Council Name and Number and Grand Knight or Program Director Name and Email are required to complete. There will also be information on the submission form that can be filled out for each of your programs/ submissions that State officers, directors, and chairmen will use to evaluate submissions and determine the award winners for the 2023 State Convention in April.

You will also have the ability to upload documents and pictures with your submission for the officers, directors, and chairmen to see.

With these new website-based submission forms, once you have completed the required information, as well as any additional information you may choose to provide, you can click the "Send" button at the bottom of the page. This will automatically send a copy of your submission to the State Program Director, any additional directors or chairmen that may need it, and your council's Grand Knight or Program Director (depending on the email you provided on the submission form). You will also see a new page on your screen saying that your submission form has been sent.

As you work on filling out your submission forms for the ICC Program, please make sure that you retain a copy of the email verifying your submission. This will be a way to double-check if there are any questions regarding form submissions.

If you have any questions or problems when using the new website-based ICC Program submission forms, you can contact several people for help. First, use the 'Contact' link at the bottom of the State Website to reach out to the website administrators. You can also contact State Program Director Brian Hamik or Assistant State Program Director Mitchell Lowery with any questions.

And don't forget, submit early and submit often. It is great to see all of the wonderful projects that happen around the State throughout the year.

2023 State Free Throw Contest




The date for the 2023 State Free Throw Contest has been set for April 15, 2023.

Let's see if we can exceed the 80 contestants from regional winners across the State of Nebraska from 2022.








Posters are due to the Youth Chairman by December 1, 2022.

With the recent Supreme Court decision concerning Roe vs. Wade, the Knights of Columbus have introduced a new program to help support mothers and babies after birth.

The program is like the RSVP Program that supports Seminarians in that for every \$500 your Council or Assembly donates to a qualified pregnancy center or maternity home (up to \$2,000), Supreme will donate \$100.

The Nebraska Culture of Life Foundation will also donate an additional \$100 to these centers upon a council or assembly that donates a \$1,000 in support.

Please remember that we still have much work in the Pro-Life area that still needs our support prayerfully, financially, and physically. We may have won a victory in June but the battle is still before us.



PSD John T. (Jack) Carpenter Loving and Faithful Servant of the Lord

Jack Carpenter, Nebraska Knights of Columbus Past State Deputy, was a loving and faithful servant of God. He died on July 14, 2022, and is remembered for many things, least of which was his strong faith and love of family.

He was born on August 5, 1936, in Bronx, New York, and attended parochial schools in New Jersey. He went on to graduate from the University of Notre Dame in 1958 and

the Fordham School of Law in 1963.

Jack was a commissioned officer in the United States Marine Corps, where he served as a Company Commander with the 9th Marine Regiment, 1st Marine Division at Camp Pendleton, California, from 1958 to 1960. He married Omaha native, Mary Virginia Clapp, at St. Philip Catholic Church on August 26, 1961.

In addition to his Omaha law practice as a plaintiff attorney from 1963 to 2000, professionally he served as president of the Nebraska Chapter of American Board of Trial



Advocates from 1978 to 1980, and was a fellow in the American College of Trial Attorneys, a member of the International Academy of Trial Lawyers and an advocate with the American Board of Trial Advocates.

PSD Carpenter was very active in the Catholic Church. He served on the high school boards at Mount Michael Benedictine, Creighton Prep, Roncalli and Marian, as well as at Madonna School and Community Based Services.

Brother Carpenter thoroughly enjoyed his 50-year history with the Knights of Columbus. During this time, he served as the Grand Knight for Santa Maria Council 5287 (1966 to 1968), several State officer positions over 16 years and State Deputy of Nebraska (1976 to 1978). Additionally, he was a member of the Serra Club of Omaha, the Archbishop's Committee for Educational Development, Nebraska Chapter President of the Catholic League, 40 years as a Eucharistic Minister, and a daily communicant until his health failed him.

PSD Jerry Smith, a long-time friend, was recruited by PSD Jack Carpenter to join the Knights in 1962. Jerry said that during Jack's long illness, he visited Jack often at his home. During this time, he witnessed firsthand Jack's strong faith in God, as well as his deep love for his family and the countless friends he made throughout his life.

Jerry also said that Jack never had a bad word for anyone and was always in the presence of a rosary, either visible or on his person, his chair or a nearby table. Jack was always interested in others and would regularly ask Jerry about his family, Jerry's brother a Holy Cross priest, Notre Dame sports, and the status of the Knights of Columbus in Nebraska.

Jerry remarked that he was inspired by Jack's strong faith in God and his deep love for his wife Mary of 61 years, for his children John, Molly and Jenny and for his six grandchildren.

May his soul, and all the souls of the faithful departed, through the mercy of God, rest in peace.




Tanner Lockhorn Joins the Swanson Agency

Campaign for People with Intellectual Disabilities October 13-16, 2022

As the summer draws to a close, we start to look ahead to the many activities we enjoy each fall. From football games to trips to the pumpkin patch, we all have activities that bring our families closer at this time of year. One activity to consider adding to your annual list is the Campaign for People with Intellectual Disabilities.

Once again, brother Knight and Governor, Pete Ricketts, has been asked to sign a proclamation declaring the week of October 13-16, 2022, as "Support Citizens with Intellectual Disabilities Week" in the State of Nebraska. To follow suit, the State Council has designated October 13th to 16th as the official dates for the campaign. Each council, however, is welcome to pick dates based on their availability.

The 2020 Campaign for People with Intellectual Disabilities was not exempt from the effects of the Covid-19 pandemic. Contributions that year were down significantly, which has forced the Intellectual Disabilities Foundation to decrease the amount we have been able to provide to organizations across the state serving those with special needs.

We were extremely encouraged to see the success of the 2021 drive as contributions were up over 65% compared to the 2020 drive! We are hoping to see this success and the strong efforts continue again this year as we work back to normal giving levels.

However, for this to happen, we need the help of all our councils. If you have not already done so, please reach out to local businesses and schedule a time where the Knights can conduct their drive.

Please speak with your parish priest about setting up a weekend to hold the drive at your parish as well. If a traditional drive does not work for your council, we "Helping People with Special Needs"

encourage you to come up with another way to raise funds. We are more than willing to help you create a plan, if needed.

As a reminder, the final report and ALL money collected are due to the Intellectual Disabilities Foundation Directors by January 31, 2023. All of the money that a council collects during the drive MUST be submitted to the Foundation.

Once the money and report are received, the Foundation will write a check(s) back to the organization(s) each council notes on their report, up to 50% of the collected funds.

The remaining 50% is used by the Foundation to provide support for special requests from organizations throughout Nebraska. Any funds that have not been requested back by a council by June 30, 2023, will be forfeited by the council and become part of the Foundation's funds.

We are counting on each of you to make the 2022 Campaign for People with Intellectual Disabilities a success. Do not hesitate to include your families and friends.

Growing up, some of my first memories of the Knights of Columbus were of helping hand out Tootsie Rolls® with my dad and grandpa.

Allowing your families to be part of the philanthropic experiences that we do as Knights help to create the memories and traditions that will live on for years to come. Remember that the Knights of Columbus is for the whole family.

Many of you know that I had a sister, Lori, with special needs. She attended Region 4 Services and lived in a group

home in O'Neill.

The first Christmas she was there, my parents bought every resident a jar of candy decorated as a Santa Claus. The staff told my parents how much the residents loved their gift and how many of them did not have any gifts for Christmas because they had no family.

This was so hard for my parents to hear, so the following year my mom

The lists we received taught us the true meaning of Christmas. The lists were simple and heart felt. Their requests included soap, Kleenex, a book, socks, and maybe a shirt. Our extended family heard about our gift giving project and wanted to be involved.





Cash Gifts

To make a cash gift, make a check payable to Nebraska State Council McGivney Foundation, and send to PO Box 98, Elkhorn, NE 68022. Or you can make an on-line gift at www.catholicgift.org. On the Southern Nebraska home page hit the DONATE button, follow the prompts to the drop-down menu where you will find the Nebraska State Council McGivney Foundation, and then make either a one-time gift or a recurring gift via electronic funds transfer (EFT), or your credit card.

Gifts of Stock or Mutual Funds

To make a gift of stock or mutual funds, contact the Catholic Foundation of Southern Nebraska at 402-488-2142, or send an email request to chris-raun@catholicgift. org. He will provide you with the instructions you need to transfer stock or shares of mutual funds directly to the Nebraska State Council McGivney Foundation.

Gifts of Grain

If you own grain that you would like to donate to the Nebraska State Council McGivney Foundation, call Chris Raun or Claire Pohlen at the Catholic Foundation of Southern Nebraska. They will provide you with simple instructions for a grain donation. If your local elevator or coop does not already have a Catholic Foundation of Southern Nebraska account, call Chris Raun at 402-488-2124, and one will be immediately opened to receive your gift (transfer of grain). The Foundation's account will receive the donation, the grain will be immediately sold and a check will be sent directly to the Catholic Foundation for depos-

it into the Nebraska State Council McGivney Foundation. There will be no fees charged by the Catholic Foundation to reduce your gift.

Memorials

People often struggle to decide where memorial money should be directed at their deaths. For an active and committed member of the Knights of Columbus, the Nebraska State Council McGivney Foundation is a natural choice for memorial gifts or planned estate gift. Memorial gifts to the Nebraska State Council McGivney Foundation will be a gift of principal, which when endowed will continue to generate ongoing gifts to the charity every year into perpetuity. It is a one-time gift that becomes an ongoing legacy gift.

Gift Acknowledgment

In all cases, once your gift is received, you will receive a gift acknowledgment letter. With the exception of grain donations, you can use the acknowledgment letter to claim a charitable deduction from your income tax. In the case of a grain donation, the acknowledgment letter will confirm and thank you for your gift. Once sold, the value of the grain sold will constitute your gift, and you will not have to pay income tax on the value of the grain donated.
