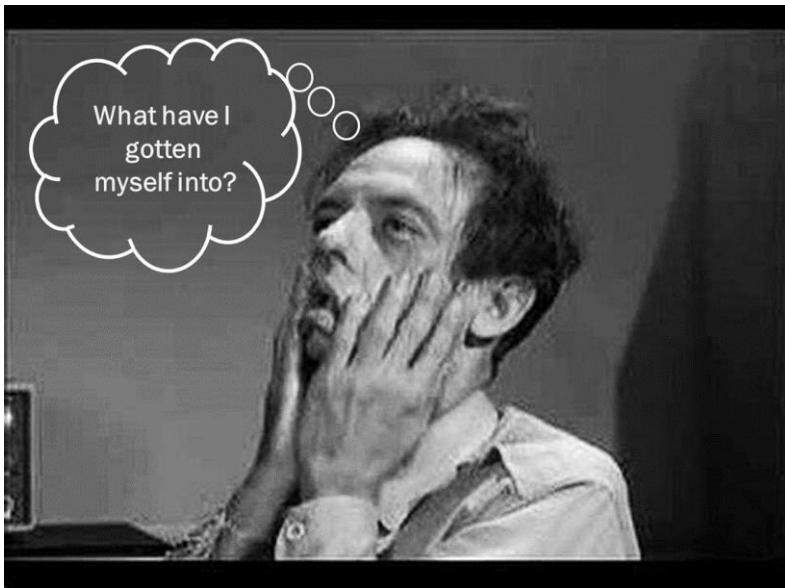

AFFILIATE MEMBERSHIP INITIATIVE

- Single biggest change in membership in my time as a Knight
- Recognizes the value of members who cannot be active in their local council
- Process will become permanent
- Less than 9% of membership effected
- Less than 1% want to quit KofC
- AMI members do not pay dues
- AMI transfers will be removed from your State Capital



AFFILIATE MEMBERSHIP INITIATIVE (Cont)

- Withdraw a member who no longer wants to be a Knight
- If an AMI member transfer back to your council, do not charge dues in the arrears
- Date extended for Phase 2 to May 31st (was April 30th)

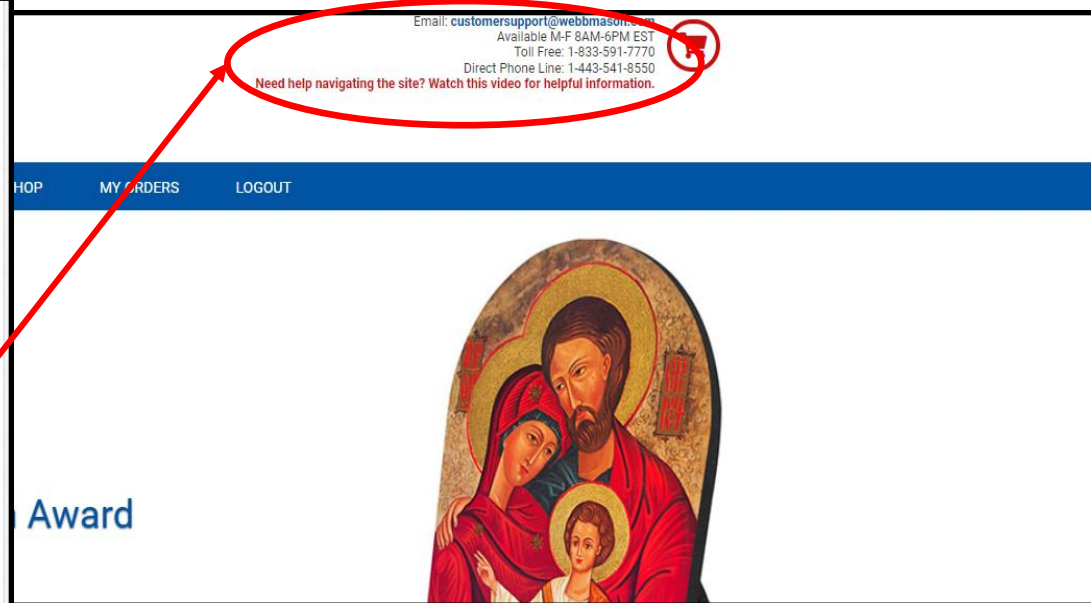
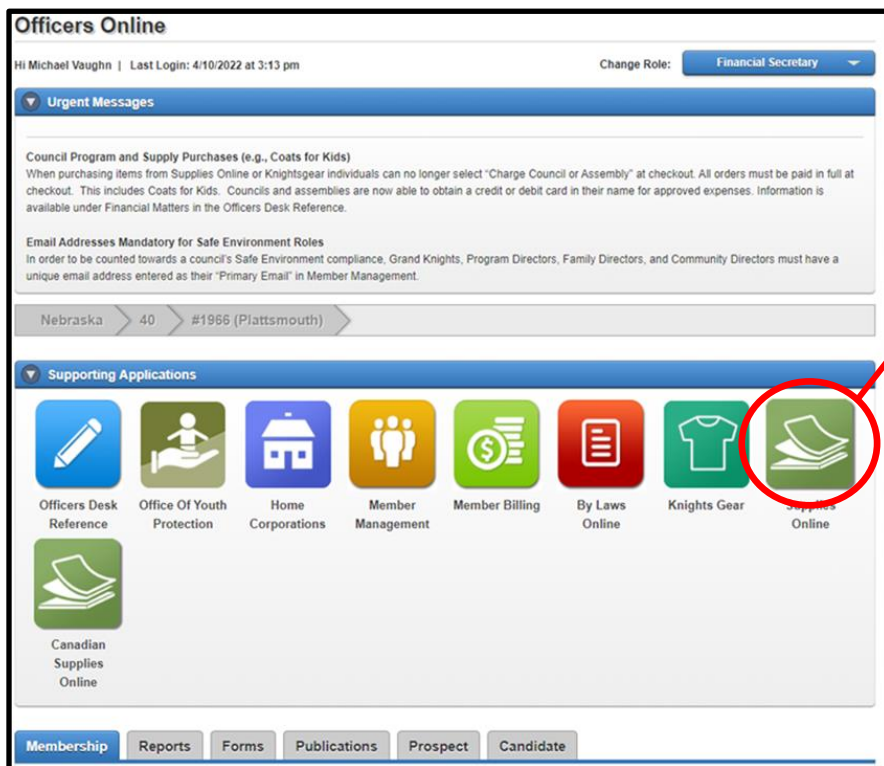
OFFICERS DESK REFERENCE

- PayPal, Square, debit cards, etc. all have guidance and requirements

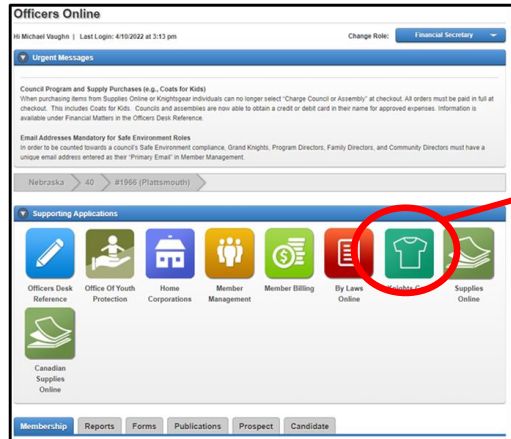


NAVIGATING SUPPLIES
