Nominations Guideline and Form

<u>General Instructions:</u> This form should be completed by the Assembly's duly appointed committee, approved by the Faithful Navigator, and submitted to the District Master no later than **March 1**st. All required information should be typed to ensure legibility. If additional space is needed to fully answer items 2 through 6, use additional paper and appropriately identify the item being continued.

<u>Eligibility:</u> Any member of any Assembly in the District is eligible, provided that the member is in good standing in his Council and Assembly.

Method of Selection: The method that each Assembly utilizes to select their Sir Knight of the Year is at the discretion of each Assembly. Factors to consider are accomplishments at Council, Assembly, State, District or Provincial level. His dedication, character, and contributions to the Order. Items to be covered are:

- 1. Nominee's Knights of Columbus history.
- 2. Positive character of the Nominee.
- 3. Devotion to and involvement with his family. (Nominee need not be married to be considered. They may be devoted and involved with their mother and father, brothers and sisters, aunts, and uncles, etc.)

- 4. Active involvement in his Council, Assembly, State Council, District or Province.
- 5. Active involvement and commitment to his community.
- 6. Active involvement in his Parish.

Begin by making a list of the Nominee's contributions in the above areas. When you are satisfied that you have completed the Nominee's contributions, complete the form by typing. Presenting the contributions under each item, using the space provided. If additional space is needed, do so as described above. Use short concise statements.
