## True Act of Thanksgiving

The past few issues I have been writing on St. Michael and his duties as Archangel. It is an amazing gift to have such a helper in the life of faith. As I reflected on St. Michael, I was also struck with great gratitude and thanksgiving for St. Michael's duties for the faithful. As we have just celebrated Thanksgiving Day, I wanted to take a moment to look at what an act of thanksgiving looks like for a Knight, for a Catholic man of faith.

I myself have been a Knight for around 27 years. I am sure many of you, my brothers, have been Knights for many more years than this. In my years as a Knight, what has changed most in me, is how I view my life as an act of Thanksgiving to God. (Greek noun  $\varepsilon \dot{\upsilon} \chi \alpha \varrho \iota \sigma \tau \iota \alpha$  - eucharistia). As Knights, our greatest act of Thanksgiving, is also found in the Eucharist. This Thanksgiving, this Eucharist strengthens us to be men of faith, to be good husbands, fathers and brothers. Without the Eucharist, there is no Knights of Columbus. Without the Eucharistic Thanksgiving, we have no source of Unity, or Fraternity or even Charity. I firmly believe as Knights, the Thanksgiving of the Eucharist is what makes us Knights. I feel most like a Knight when I am surrounded by brothers around the Eucharistic sacrifice, the Truest Act of Thanksgiving. Here we encounter Christ, we receive Christ and we live what it means to be a Knight. Christ unites us in His precious Body and Blood as one. Be a Knight of Thanksgiving, be a Knight united in the Eucharist. Offer your act of Thanksgiving to God, receive from Him your commission as brothers in Christ, as Knights of Columbus.

## 2021 State Lottery Tickets Distributed in February

The distribution of the 2021 State Lottery tickets will be by mail. Every Nebraska Knight will receive three lottery tickets around the middle of February and you may start selling them immediately. All proceeds are deposited into the States' lottery account and those funds support the young men and women who have responded to God's call.

You may return your filled-out tickets (only return the half with the contact information) and money by mail. You can also return them at the April 2021 State Convention. If you are mailing the tickets back, return them no later than April 19, 2021 to ensure they get into the drawing. Please return the unsold tickets as well because I will mail them back out to those Knights requesting additional tickets. Thanks for all you do and let's make this our best year yet.

## Rev. Charles J. O'Rourke November 1, 1930 ~ November 6, 2020

Father Charles Joseph O'Rourke died on November 6, 2020 in Papillion, NE. Father O'Rourke was born on November 1, 1930 in Missouri Valley, IA to Charles O'Rourke and Mary (Walsh) O'Rourke.

Father o'Rourke joined the Columban Fathers as a high school student and was ordained at St. Columban's Major Seminary in Milton, MA in 1957. From 1958 till 1985, he served on the missions in South Korea. Upon returning to the United States, he pastored Korean Catholic communities in Chicago, Los Angeles and Omaha. After a transfer to the Columban headquarters in Bellevue, he continued ministry to the Korean Catholics and to Contemplative Prayer.

It comes with a heavy heart to learn the passing of Fr. Charles O'Rourke. He loved the Knights and was wonderful supporter of humanity. A few months into my first year as State Deputy, we redesigned the state ethnic group approach, broadening our support to ethnic families in Nebraska. Working with Fr. John Burger, Director of the National Columban Fathers, Fr. O'Rourke provided our state with four ethnic advisors for the Philippines, Hispanics, Vietnamese and Koreans. Fr. O'Rourke agreed to be our State Korean Family Advisor. We worked together over many lunches and had a great plan to move forward. Then the pandemic hit.

The plan is still in place for our next administration as the pandemic hopefully will be controlled by July 2021. I thank God we were able to have Fr. O'Rourke on our team as a state advisor for our Korean Catholic brothers, their families and as a wonderful blessing for humanity. God rest his soul. We will miss and pray for you Father O'Rourke.



# **Per Capita:** Keep Your Council in Good Standing

#### Per Capita Due March 1, 2021

Every billable member of the Knights of Columbus is assessed by State and Supreme Councils. This state assessment is the per capita invoice each council's Financial Secretary receives twice each fiscal year. This payment does not require a council vote, so prompt payment should not be an issue. Per capita is to be paid with council dues.

Currently, the State Council assessment per billable member is \$8.75, with \$4.37 to be billed January 1, 2021, due March 1, 2021; and \$4.38 billed July 1, 2021, due September 1, 2021. Remember, disabled and honorary life members are not billable members.

### Late Payment Risks Suspension

As your State Secretary, I am responsible for billing and collecting per capita payments. While a majority of our Nebraska councils remit payments on time, a few councils miss the deadline for paying this assessment. The Grand Knight and Financial Secretary of each of these councils will then receive a second-notice billing. While prompt response to second notices helps avoid possible suspensions, but a late payment also disqualifies councils for all State and Supreme awards handed out during our annual State Convention in April.

As many of you have probably seen, we have released an update to the state website. If you have not seen it yet, I invite you to take a look at https://nebraskakofc.org/

The look and feel of the website have changed quite a bit, but the information is still there. By this time, councils should have already kicked off this year's Intellectual Disabilities Campaign. The campaign began during October 8-11, 2020. Many councils have conducted their drives and are sending reports to me. Be aware that there is still plenty of time to conduct your campaign. There Is no reason that councils cannot conduct more than one campaign. Due to the COVID Virus, this is even recommended. My council in Fort Calhoun conducted a drive in October. We have another one scheduled for the second week in December.

Don't give up too soon! Remember, all monies collected go to the agencies that work with intellectually disabled individuals. **Report Forms:** Each council needs to submit a report form to me when you feel your drive is completed.

Forms and checks should be mailed to me at the address provided on the report form. The form is a duplicate form. Be sure all information is complete and all math is correct.

I will print checks made out to the designated agencies you identified and return the checks based on the information that you provided. All checks to your designated agencies will be mailed directly to the Grand Knight. It is his responsibility to get the checks to those agencies.

As we are entering the new year it is time to concentrate on the upcoming One Rose, One Life Campaign to support the Pro-Life efforts here in Nebraska. This campaign is the primary source of income for the Culture of Life Foundation (COL) and with these funds we are able to provide funding to many pro-life organizations across the state. With COVID still hanging around we must look at creative ways to raise funds and continue supporting the COL.

## **Call for Life Program**

Call for Life is a new program that we are introducing to councils to participate in and it offers you a new and creative way to support the One Rose, One Life Campaign. How does it work? It's as easy as:

- Set a goal amount that your council wishes to raise for the One Rose, One Life Campaign
- Have your local Pro-Life director develop a team of supportive brothers
- Divide the amount each team member needs to raise (i.e. Goal \$2,000/ 10 team members/ each needs to raise \$200)
- Call family, friends, parishioners, co-workers and ask them to support this campaign
- Record all donations, forward to each donor a selfaddressed envelope, a thank you note and a One Rose, One Life prayer card.

• Collect all funds in a timely manner and send all funds to Culture of Life Foundation by March 1st in order to be eligible for council division awards

A suggested calling script and prayer cards will be sent to each council along with a detailed description of the program in coming weeks.

I have received calls from many councils who feel that they have been stagnant because of COVID and they are looking for ways to get involved and to get their membership involved. This coming January, we as Catholics, and we as Knights must stand together and send a clear and direct message to our local communities, state and national leaders that life is sacred, life is dear and that life is from conception to natural death.

- January to April 2021- Hold a Buck-A-Month Drive to establish funds for local pro-life efforts
- January to March 2021- Solicit essay entries for the 2021 Essay Contest. Theme to be announced at a later date.

- Only members or wives, widows or daughters of Knights of Columbus members are eligible to bowl.
  - Proof of eligibility will be checked before bowler is permitted to bowl.
- Teams and doubles can be made up of any combination of men and women.
- No more than 3 bowlers may comprise a second entry and place in the standings Entrants may bowl on more than 1 team subject to these conditions. First Team and First doubles bowled will count towards All Events.
  - There will be no more than one entry per bowler in Singles and All Events 5.
- Bowlers must enter both doubles and singles. You may enter doubles more than once, but can only cash once with the same partner. You may cash as often as you change partners 9.
  - Handicap will be 90% of the difference between bowlers average and 200. . 8. 6.
    - All handicaps will be figured for each bowler-not a team basis.
- Entrants will use their highest USBC sanctioned league average for 21 games or more for last season, except if current season high average, for 21 games or more, is 10 pins or higher than last season's high book average, he/she will use current average as of December 31, 2020.

All other bowlers will use a 160 average for men and 120 average for women.

- 10. Tournament officials will check averages before awarding and prize money.
- 11. All bowlers should be aware and familiar with USBC rule No. 319A-1,2,3. Failure to use proper average or make corrections prior to completion of the first game of series shall disqualify score if submitted average is lower than actual average of base prize winnings on submitted average if it is higher.
  - 12. All errors must be claimed within 24 hours, or score is official.
    - 13. Lanes will be assigned by bowling alley personnel.
- 14. No refunds after closing date except in extreme emergencies. Host councils will make the final decision.
- 15. No entries scheduled without payment in full. Tournament director reserves the right to assign different times other than what is on the entry form.
  - 16. Prize Fee returned 100%. Ratio 1for 4 in Team, Doubles and Singles, 1 for 10 in All Events
    - 17. Tournament prize winnings need not be reported.

## **Cash Gifts**

## Gifts of Stock or Mutual Funds

## **Memorials**




