Grand Knights, Financial Secretaries, and Council Intellectual Disabilities Chairmen:

This packet is designed to assist you and your council with the annual **Campaign for People with Intellectual Disabilities**, formerly known as the Tootsie Roll Drive.

Your **first responsibility** in participating in the campaign is to **order your cases of Tootsie Rolls by August 1st**. Many councils combine their Tootsie Roll orders with other councils in their district in an effort to save on freight costs. Orders of 33 cases or more receive free shipping. Ordering requirements are outlined on the Knights of Columbus Tootsie Roll Order Form found in this packet as well as on the website at www.nebraskakofc.org. Coordinating orders through your District Deputy is also helpful. Check your supply of canisters and/or hats as these are ordered when you order the Tootsie Rolls.

In addition, you need to **publicize the campaign** in advance and to **solicit donations** from businesses by encouraging them to buy a case of Tootsie Roll candies. Certificates of Merit are included in this packet as a way to recognize businesses who buy a case of Tootsie Rolls as well as to recognize businesses or individuals who make large donations during the drive. Showing your appreciation as Knights increases good will in your community. The certificates could also be used to recognize your council's volunteers in appreciation for their time and effort in working to make the campaign successful. And, of course, you need to follow through and actually **conduct the drive** in your community.

The Nebraska Jurisdiction of the Knights of Columbus has councils varying in both size and setting. If your council runs a successful Campaign for People with Intellectual Disabilities and you want to share what works for you along with what doesn't work, please contact the Intellectual Disabilities Director, your District Deputy, or a member of the Nebraska State Council.

Extra order forms and reporting forms are available on the Nebraska Knights of Columbus website (www.nebraskakofc.org). They are currently located in the "Programs" tab of the "Home Page" under "Intellectual Disabilities" or from the State Intellectual Disabilities Directors.

One of the goals of the Knights of Columbus in Nebraska is to serve people with intellectual disabilities in the best way possible. The money collected through the Campaign for People with Intellectual Disabilities allows the Knights to donate thousands of dollars to serve these special people through numerous groups dedicated to addressing the needs of the intellectually disabled.

2022 Timeline

Nebraska Knights of Columbus

July 2022

Select local chairman to head Campaign for People with Intellectual Disabilities (formerly known as the Tootsie Roll Drive)

****Decide how many cases of Tootsie Rolls are needed and order them by AUGUST 1, 2022. Check supplies including vests, canisters, and hats. Order them on the Tootsie Roll order form.**

August 2022

****ORDERING DEADLINE for Tootsie Rolls, collection canisters, etc. is AUGUST 1, 2022.**

****Be sure to mark the appropriate box requesting canisters on the Tootsie Roll order form.**

Recruit area captains

Assign areas for captains

Area captains recruit volunteers

Council should discuss distribution of funds to determine a group to support

September 2022

Arrange for the local mayor or official to sign proclamation and take a photo for publicity

Finish recruiting local volunteers

Issue press release including local proclamation and photo along with campaign dates

Train and educate local volunteers

October 2022

Hold local Campaign for People with Intellectual Disabilities

October 13, 14 15, and 16, 2022, are the suggested dates

Collect money and tabulate results

Issue local press release announcing local results

TO GRAND KNIGHTS, FINANCIAL SECRETARIES, DISTRICT DEPUTIES, AND COUNCIL TOOTSIE ROLL CHAIRMEN:

In 1976 the Nebraska Knights of Columbus began the Tootsie Roll Program to benefit children and adults with intellectual disabilities. The general public has supported this program through contributions during the annual fundraising drive.

This year's Campaign for People with Intellectual Disabilities, formerly called the Tootsie Roll® Drive, will be held on October 13, 14, 15, and 16, 2022. All forms needed for the drive and the report forms to be sent to the Intellectual Disabilities Directors are included in the packet that was distributed at the Leadership Training Seminar in Grand Island. Half of the money raised from the drive will be returned to the councils to be given to a qualifying charity of their choice. The checks will be made out to the charity and then sent to the council for presentation to the charitable group.

The State Council's Intellectual Disabilities Foundation of Nebraska, Inc. used the state's half of the 2021 funds collected for donations to the following groups:

Special Olympics of Nebraska	\$ 11,000.00
Ollie Webb Center	\$ 2,000.00
Madonna School and Workshop - Omaha	\$ 13,000.00
Villa Marie School - Waverly	\$ 15,500.00
Mosaic	\$ 10,000.00
S.M.I.L.E Inc.	\$ 7,500.00
Buckboard Therapeutic Riding Academy	\$ 7,500.00
D.U.E.T. Foundation	\$ 10,000.00

You may notice that some of these amounts are lower than they have been in previous years. This is due to the fact that less money was received in the 2020 Campaign for People with Intellectual Disabilities compared to previous years, mainly caused by the COVID-19 pandemic. We saw a strong rebound in 2021 and are hoping to see that again in 2022 so we can bring our donations back up to the giving level that the Intellectual Disabilities Foundation of Nebraska, Inc. is used to providing.

Some funds are kept in reserve for special projects throughout the year. This annual Campaign for People with Intellectual Disabilities helps support many different organizations in the state. Thanks to the generosity of many Nebraskans and the hard work of dedicated Knights, nearly \$5,000,000 has been distributed since 2001. Keep up the good work!
