## Words from our State Chaplain

# **LOTTERY DRAWING WILL TAKE PLACE Even though the Convention Is Cancelled!**

The State Lottery Drawing will be held the weekend of April 24th–26th, 2020. Information will be provided as we determine a way to "live-stream" the drawing. Tickets are \$10.00 each and there are nine prizes this year: \$2,500; \$1,000; \$750; \$500 and five \$100 prizes.

By now, you have received three 2020 State Lottery tickets in the mail. The money raised by selling these tickets helps support our 67 Seminarians and Vocation projects across our great state.

In order to mail out the lottery tickets, the Nebraska Gaming Commission required us put in "it is not necessary to purchase the ticket to be entered into the drawing" on each ticket. This has caused some confusion.

Our goal is to raise money for Vocations and the only way we'll do that is for our members to return the filled out portion of the lottery tickets with \$10 per ticket. Together, with your prayers and financial support, we'll make this year's annual lottery a huge SUCCESS for our beloved Seminarians.

Because the Convention was cancelled, all tickets and money MUST be returned by mail or hand delivered. They must be received by the State Warden no later than Monday April 20th, 2020. # Intellectual Disabilities Campaign at 83% Participation Asking for 100% before Fraternal Year End

This year's intellectual disabilities campaign was a big success. Thank you to all of the councils that participated this year. Of Nebraska's 172 councils, 143 or 83 percent filed a report before the January 31 deadline to be considered for an ICC award.

Congratulations to Division 4 Councils on achieving 100 percent participation with all 39 councils reporting before the deadline.

By division, here is the participation breakdown: Division 1: 34 councils out of 50; Division 2: 34 councils out of 44; Division 3: 36 councils out of 39; and Division 4: 39 councils out of 39.

Total money collected this fraternal year is \$207,000. Half of that collected is designated for distribution to organizations that work with intellectually disabled individuals chosen by the councils. So far during this fraternal year, checks totaling \$44,100 have been returned to Nebraska councils for distribution to their chosen organizations. The Foundation retains the other half for financial support of state 501(c)(3) organizations such as Nebraska Special Olympics, Madonna School, ARC, Mosiac and Villa Marie School and Smile.

While it's too late to be considered for an ICC award for 2019/2020, those councils that didn't submit a report are encouraged to send one in. To those councils in Divisions 1, 2 and 3 that may not have had a fund drive, please prayerfully consider submitting a donation of at least \$100. Let's reach 100 percent participation!

### **BE A SUPREME DELEGATE**

2020 Supreme Convention in Washington D.C. August 4-6, 2020 Tours and events starting August 1, 2020

Being optimistic, Supreme has planned their 138th annual convention in Washington D.C. Every 3rd Degree member of the Nebraska Knights of Columbus is eligible to represent the State Council as a delegate to the 138th Supreme Convention in Washington D.C., August 4-6, 2020. If you are interested in running for Supreme Delegate, contact your Financial Secretary.

#### Mandatory for a Supreme Delegate:

You will have to pay all expenses such as travel, hotels, and meals yourself. The State cannot help you. You will receive a reimbursement check at noon on Thursday, August 6. Delegates are reimbursed at the rate of \$400 per diem for lodging and meals and paid \$.30 per mile for the first 1,500 miles and \$.20 per mile over 1,500 miles.

- You must be a 3rd Degree member.
- You must have a credit card.
- You will need a white dinner jacket. Most rent one.
- You must stay in the convention hotel, the Washington D.C. Hilton.
- You must attend all business meetings.
- You must attend the Annual (Supreme Council) States' Dinner on Tuesday evening. The
  cost of the delegate's dinner will be deducted from your reimbursement check. You must
  pay for your spouse's dinner when completing your registration.
- The State Council will host a dinner Wednesday evening. The State Council will pay for your (and spouse's) meal. The Nebraska Bishops also attend.

Delegates will be chosen during the proposed Virtual State Convention the weekend of April 25-26, 2020. Watch for further updates on this meeting. (Also see pages 1, 3, and 5).

#### **Memorials**


